## 4. First-Aid Measures

# 5. Fire-Fighting Measures

**UNUSUAL FIRE AND EXPLOSION HAZARDS:** FLASH POINT IS LESS THAN 20°F. EXTREMELY FLAMMABLE LIQUID AND VAPOR!Water spray may be ineffective. # 6. Accidental Release Measures

# 7. Handling and Storage

STORAGE: Keep containers tightly closed. Isolate from heat, electrical equipment, sparks and open flame. Contents under pressure. Do not store above 120 ° F. Store large quantities in buildings designed and protected for storage of flammable aerosols. Product should be stored in tightly sealed containers and protected from heat, moisture, and foreign materials. Store in a dry, well ventilated place. Keep container tightly closed when not in use. #### PERSONAL PROTECTION

# 10. Stability and Reactivity
