## 4. First-Aid Measures

## 5. Fire-Fighting Measures

## 10. Stability and Reactivity

Conditions to Avoid: Avoid all possible sources of ignition.

Incompatibility: Incompatible with strong oxidizing agents, strong acids and strong alkalies.
